Claims Submission Process

Horizon NJ Health Claims - Provider Services Line -1-800-682-9091

- » Horizon NJ Health encourages all hospitals, physicians and health care professionals to submit claims electronically. Horizon NJ Health encourages all hospitals, physicians, and health care professionals to submit claims electronically. We utilize the TriZetto Provider Solutions (TTPS) Direct Data Entry (DDE) SimpleClaim system. All providers that previously used TriZetto to directly enter their Horizon NJ Health claims must switch to DDE SimpleClaim. For Medicare members, Medicare must be billed first and the EOB should be later submitted to Horizon NJ Health. For DSNP members, claims should be submitted directly to HNJH.
